STUDENT'S RIGHT TO CANCEL

STUDENT'S RIGHT TO CANCEL: The student has 7 business days after the first class attended (the cancellation period), to cancel the enrollment agreement for a course of instruction, including the return of any books and supplies. A business day shall be defined as a day on which the student was scheduled to attend a class session.

The refund policy applies to all terminations for any reason, by either party, including student decision, course or program cancellation or school closure.

The notice of cancellation shall be in writing and submitted directly to the Financial Aid Office, a withdrawal may be initiated by the student's written notice or by the institution due to student's academics or conduct, including, but not necessarily limited to, a student's lack of attendance.

<u>After the cancellation period</u>, the institution provides a pro rata refund of the scheduled hours ALL funds paid for tuition charges to students who have completed 60 percent or less of the period of attendance. Once more then 60 percent of the enrollment period in the entire course has incurred (including absences), there will be no refund to the student.
