HYPOTHETICAL EXAMPLE:

Assume that a student, upon enrollment in a 700-hour course, pays \$5800 for tuition, including a \$250 registration / deposit fee, and withdrawals after completing 50 hours. The refund to the student would be \$4757 based on the calculation below.

- 1) \$5800 paid \$250 registration fee = \$5500 for instruction
- 2) \$5500 for instruction / 700 hr. = \$7.86 for instruction / hr.
- 3) 50 hr. x \$7.86 for instruction / hr. = \$393 for instruction
- 4) \$393 for instruction + \$250.00 registration / deposit fee = \$643 retained by the school
- 5) The refund amount is \$5800 \$643 = \$4757
