Definitions

- "Number of Students Who Began the Program" means the number of students who began a
 program who were scheduled to complete the program within 100% of the published
 program length within the reporting calendar year and excludes all students who cancelled

- "Students Available for Graduation" is the number of students who began the program minus the number of students who have died, been incarcerated, or been called to active military duty.

- "On-time Completion Rate" is the number of on-time graduates divided by the number of students available for graduation.
- "150% Graduates" is the number of students who completed the program within 150% of the program length (includes on-time graduates).

STUDENT'S RIGHT TO CANCEL

CANCELLATION POLICY

A student has the right to cancel the enrollment agreement and obtain a refund of charges paid through attendance at the first class session, or the seventh day after enrollment, whichever is later. Cancellation in person can occur when the student gives written notice of cancellation at the institution. You can do this by mail or hand delivery. The written notice of cancellation, if sent by mail, is effective from the date of the postmark.

The written notice of cancellation need not take any particular form, however expressed; it is effective if it shows that you no longer wish to be bound by the enrollment agreement.

If you cancel the enrollment agreement, the school will refund all monies that you paid, less a registration fee not to exceed \$100.00 within (45) calendar days.
