There is not any entrance-testing requirement. Cypress does not provide English as a second language instruction. Cypress does not offer ESL classes or translators. The student must have the ability to read and write English at the level of a graduate of an American high school as demonstrated by the possession of a high school diploma, GED or passage of the California high school proficiency exam. Students are taught to give a nurturing massage and to help alleviate pain and provide other symptomatic relief. Another objective is to help students acquire insight into the dynamics of the healing process and an understanding of the underlying causes of disease. Students will also begin to understand anatomy of the human body with its structural and functional interrelationships. Finally, a student will begin to develop the self-confidence and intuitive freedom to trust his/her innate healing abilities.

### **NOTICE CONCERNING TRANSFERABILITY OF CREDITS AND CREDENTIALS EARNED AT OUR INSTITUTION**

### **STUDENT TUITION RECOVERY FUND**

To be eligible for STRF, you must be a California resident or are enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120-day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of said institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

### **Facility, Equipment and Student Services**

Cypress is located in downtown Santa Cruz above Planned Parenthood in the Logos Building, a large and well maintained building.

- Two large, clean, light-filled classrooms, with 2 restrooms are available for classes.
- Massage tables and Massage chairs are available for student's use while in class.
- Both a projector and projection screen are available for powerpoint presentations.
- A skeleton is available to students in the classroom.
- Reference books, including but not limited to the following are available in the classroom for student use:

- A large whiteboard is available for teacher and students to use during class.
- Filtered water is available for students.
- Public transportation is available in front of the school.
- Ample, off-street parking is available at the school.
- Student handouts of material, when needed, are provided to the students for each class at no cost to the students.
- Student services: A whiteboard listing of job openings and inquiries from local businesses is available for viewing whenever students are at school.

### **Library**

Cypress does not offer a library. There are no library services available at Cypress. Cypress does provide students access to classroom educational resources, which include a skeleton, muscle, skeletal and other anatomical charts, copies of anatomy, pathology and physiology books.

### **Housing information**

Cypress does not have any dormitory facilities. The school has no responsibility to find or assist a student in finding housing. ### **Student Records**

Cypress retains student records for 5 years and transcripts are kept permanently. Students shall contact the Director, Larry Bernstein, in order to get a copy of their records and/or transcript.

## **RULES OF OPERATION**

### **Attendance Policy**

Course attendance is documented daily and all clocked hours are included in the

scheduled start and finish dates and times of each class in any course. Classes start on time and important information is presented at the beginning of class. The Institution requires all students to attend classes in each course on a regular and consistent basis in order to develop the skills and aptitude necessary to compete in the highly competitive labor market. Since much of each class is conducted in a hands-on environment, attendance is critical to proper skill building. Actual attendance time is expressed in terms of clock hours.

Clock hours will be rounded off to the nearest 1/4-hour. It is important to arrive on time or before the beginning of the scheduled class or lab period. A 96% total attendance record of the Massage Therapist Certificate Program 556-hour is required to graduate. Make-up hours are required if a student falls below the 96% attendance record.

Missed time due to tardiness or leaving a class early will be recorded and students will be required to make-up that time by paying for and attending a make-up class. Any student who misses more than 15 minutes of a 4 hour class in any program, or more than 30 minutes of a 8 hour class in any program, will not be given transcript credit for that missed class time until the student attends a make-up class for the time they missed

**Applicants for CAMTC certification must attend 500 supervised hours total with 100 of those hours satisfying CAMTC specified subject. Cypress Health Institute will record any absences and track and record all make-up sessions to insure student completion of the required hours mentioned above.**

### **Make-up Hours Procedures**

Students must make up missed hours. Students are required to attend scheduled makeup classes at the student's current program level or arrange tutorial hours with the instructor.. Students will be charged \$40/hour by the instructor for their make-up session time.

Attendance and/or graduation from a California Massage Therapy Council approved school does not guarantee certification by CAMTC. Applicants for certification shall meet all requirements as listed in California Business and Professions Code section 4600 et. seq

Cypress Health Institute uses a pass/fail system of evaluation. A student passes upon demonstrated proficiency in and knowledge of the area of study taught in the program.

### **Completion and Graduation Requirements**

Cypress Health Institute uses a pass/fail system of evaluation. A student passes upon demonstrated proficiency in, and knowledge of, the area of study taught in the program.

Such demonstration will be evidenced through the practical application of skills at the end of each course. A student must complete each course by the end date of that course. If, due to illness or emergency, a student cannot demonstrate proficiency in a course at the time that any course ends, then a student is allowed 3 months after the completion date of a course to demonstrate proficiency in that course. If a student fails to meet these requirements, then the student can request, in writing, to demonstrate proficiency after

the 3-month period. This written request may be by postal mail or email.

To complete and graduate from the Massage Therapist Certificate Program 556 hours, a student must attend at least 500 clock hours of classes in the program. A 96% total attendance record of the Massage Therapist Certificate Program 556-hour is required to graduate. Make-up hours are required if a student falls below the 96% attendance record.

Students must complete all class assignments to graduate. Students must pass all class assessments to graduate.

Applicants for CAMTC certification must attend 500 supervised hours total with 100 of those hours satisfying CAMTC specified requirements in core subjects (64 hours of Anatomy & Physiology, 13 hours of Contraindications, 18 hours of Business & Ethics, 5 hours of Health & Hygiene). Cypress Health Institute will record any absences and track and record all make-up sessions to insure student completion of the required hours mentioned above. Students must make up missed hours. Students are required to attend scheduled make-up classes at the student's current program level. Students will be charged by the instructor for their make-up session time.

Attendance and/or graduation from a California Massage Therapy Council approved school does not guarantee certification by CAMTC. Applicants for certification shall meet all requirements as listed in California Business and Professions Code section 4600 et. seq.”

### **Hygiene, Dress Code and Draping Policies**

Students are required to be clean and neat while attending all classes at Cypress Health Institute. Bodies and clothing should be scent free during class times. Professional draping techniques are taught and used for all classes requiring exposure of client body parts and skin.

### **Certificate of Completion**

When a student successfully completes all aspects of the program, the student will receive a Certificate of Completion from the Cypress Health Institute. Cypress does not offer any degree programs.

### **Student Conduct: Probation and Dismissal Policy**

Disrespectful, disruptive or unsafe behavior may be cause for probation and/or dismissal. A student who behaves in this manner three times will be put on probation for a period of two weeks. If the behavior occurs again during this period, the student will be dismissed. If the behavior recurs after the two-week probation, the student will also be dismissed.

### **Student Rights and Grievance Procedures**

A student or any member of the public may file a complaint about the institution with the

The school director, Larry Bernstein, is designated to receive and resolve student grievances. A student may lodge a complaint by communicating verbally to the director in person at the school, 1119 Pacific Avenue, #300, Santa Cruz, CA 95060. The Director is available 9:00 A.M. - 5:00 P.M. Monday through Friday.

After receiving a complaint, Cypress Health Institute shall, within ten days of receiving the complaint, provide the student with a written response, including a summary of the school's investigation and disposition of the complaint.

Larry Bernstein will be regularly accessible to all students during their time of study at Cypress Health Institute. As director, Larry Bernstein has the duty to investigate complaints thoroughly, including interviewing all people and reviewing all documents that pertain to the complaint. He shall also record a summary of the complaint, its disposition and reasons. He shall place a copy of the summary, and other related documents, in the student's file and make an appropriate entry in the log of the student's grievances.

The director will implement reasonable policies to avoid similar complaints in the future and communicate directly to any person regarding a complaint. The director may compromise or resolve the complaint in any reasonable way. If the complaint is valid and not resolved within thirty days after it was first made by the student, the director will notify the Council and authorities of the complaint investigation and resolution or lack of resolution. The director may also reject the complaint if, after investigation, it is determined to be unfounded. A student's participation in the grievance procedure and disposition of a student's complaint shall not limit or waive any of the student's rights.

### **Leave of Absence**

Submitting a written request, a student may request a leave of absence from the program for up to one year. Personal health issues and family emergencies are reasons a leave of absence may be approved. The student will have one year from the date of the written request to return and complete the program.

### **Massage Licensing**

The training received from the Cypress Health Institute will meet the requirements to practice massage in California, along with most of the United States. However, since

**Cancellation Withdrawal and Refund Policies**

The student has the right to cancel and obtain a refund of charges paid through attendance at the first course session, or the seventh day after enrollment, whichever is later. ### **Refund Information**

In addition, the student may withdraw from this course after instruction has started and receive a pro rata refund for the unused portion of the tuition and other refundable charges if the student has completed 60% or less of the instruction. For example, if the student completes only 40 hours of a 520 hour course and paid \$7500 tuition, the student would receive a refund of \$6923.08:

If a student has received federal student financial aid funds, the student is entitled to a refund of monies not paid from federal student financial aid program funds. If a student obtains a loan to pay for this program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund.

If the student defaults on a federal or state loan, then 1) the federal/state/agency may take action against the student, including garnishing an income tax refund; and 2) the student may not be eligible for any other government financial assistance at another institution until the loan is repaid.

**Course Lecture Lab Total Anatomy 77 30 107**

#### **Course Description:**

This course is catered towards bodyworkers of all types who want to further their knowledge of the body. We will explore the various muscles and anatomical landmarks using palpation and other methods to further develop your understanding of the amazing human body. This basic Anatomy course is a unique hands-on approach to the neuro muscular-skeletal system as well as its supportive and integrative systems. Students learn to feel, visualize and understand the body's interrelationships, in an integrated way and will be able to approach massage with a working knowledge of the anatomy and structure of the human body.

**Title:** Anatomy

### Course Objectives:

- Understand basic anatomical language
- **SWBAT** identify bony landmarks on body, origin and insertions of muscles and connective tissue
- Understand planes of reference, bony structures, classifications of movements and joints, muscle and connective tissue terminology
- Recognize and understand connective tissue structures and aponeuroses
- Recognize and understand fascia and it's role in muscle structure, body structure and massage
- Perform supervised palpation of musculoskeletal structures
- Identifying, locating and describing actions of individual muscles
- Identifying, locating and describing actions of muscles groups including agonists and antagonists
- Understand the muscles of the integumentary system
- Palpation techniques for the integumentary system
- Recognize and palpate the structure and muscles of the respiratory system
- Understand the nervous system pathways in the body and palpation techniques for release of nerve pain in massage

- Understanding the integumentary system- basic anatomy and function of the skin • Knowledge of the basic anatomy and function of a muscle, types of muscle tissue smooth, striated, cardiac. Sliding filament model of muscle contraction. Muscle contraction and the skeleton, types of muscle contraction- concentric, eccentric, isometric
- Knowledge of the skeletal: basic anatomy of the bones, types of bones, function of the skeleton
- Knowledge of basic human anatomy and the functions of the heart, blood and circulatory system. Pathway of blood through the heart, cardiac conduction system. • Understanding of the basic anatomy and function of the lymph system • Knowledge of the basic anatomy and function of the respiratory system, including the respiratory tree, alveoli, and muscles of inspiration and expiration • Knowledge of the basic anatomy and function of the Kidneys and Urinary System. Production of urine- filtration, absorption, secretion. Regulation of the bodies’ pH

Jordan earned his license to touch through Santa Barbara Body Therapy Institute in 2008 where he began his career of bodywork and teaching. Stemming from a neuromuscular based practice into the science of touch and healing, helping humans understand and inhabit their bodies has taken him across the globe in ways he never imagined.

Each instructor shall maintain their knowledge by completing continuing education courses within their subject area, along with classroom management or other courses related to teaching.

Each faculty member shall complete at least one course of instruction every two years and provide documentation to Cypress of their successful completion of that program.
