STUDENT'S RIGHT TO CANCEL

DROP / WITHDRAW COURSE(S) and TUITION REFUND

Students not attending a class in which they are enrolled must drop or request to withdraw from the class; failure to do so will result in a failing grade on the student's record.

Full Refund:

To obtain a full refund, a student must submit a drop form/request no later than the seventh (7) day after Term begins. If a student is unable to do so an e-mail from university issued account to the Registrar stating your request will be accepted. Deadline to drop course(s) and obtain a full-refund: <u>SUNDAY, XXX_XX, 20XX</u>. A \$50 drop fee will apply for each course that is dropped after the deadline.

Pro rata Refund:

If a student chooses to drop a course after seventh (7) day after Term begins, a student may obtain a pro rata refund for the unused portion of the tuition without receiving W grade if 20% or less of the course time has lapsed.

A Student wishing to withdraw course(s) after 20% of the course time has lapsed. A withdraw course form is required to be submitted and Withdrawal (W) grade will be issued. The effective date of withdrawal is the date emailed, postmarked or turned in to the Registrar.
