#### **REFUND CALCULATION GUIDELINES**

### **Definitions**

#### **REFUND CALCULATION GUIDELINES**

The refund policy for students who have completed 60 percent or less of the period of attendance shall be a pro rata refund. i.e for students who enroll, begin classes, and withdraw anytime after the 7-day period refunds will be calculated on a pro-rata based upon the percentage of the number of course hours scheduled to be completed at the time of withdrawal to the total length of the course less the registration fee and equipment/book kit cost. HYPOTHETICAL EXAMPLE: Cosmetology course 1600/hrs in length. Student was scheduled to attend 600 hrs. by the date of the withdrawal, which equals to 38% that is due the school. (38%) is then multiplied by the tuition (\$16,000) equaling \$6,080 plus registration fee (\$75) Kit (1,512 includes tax) STRF fee \$8.00) equals \$7,675 total due the school Note: If the student had paid for the course in full then the school would owe the student the difference between total paid and total due school. If the student had not yet paid the school the total due of \$7675 then the student would owe the school that amount before the school would be obligated to provide the student with a Proof of Training of the hours completed.
